Alpha Kappa Alpha Educational Advancement Foundation

At the heart of EAF's commitment is the idea that academic excellence comes in many forms. Candidates must be a full-time and currently enrolled graduate student at an accredited campus-based degree-granting institution.

Public Employee Retirement Research and Administration Scholarship

The Public Employee Retirement Research and Administration Scholarship (\$4,000) is available for award to a graduate student in public administration, finance, business administration, or social sciences.

The American Institute of Certified Public Accountants Student Scholarship Program
